The Interamerican Association for Environmental Defense (AIDA) is a nonprofit international environmental law organization that aims to protect the right to a healthy environment in the Americas, with a focus on Latin America. We provide legal and technical assistance free of charge to communities and organizations working to protect natural resources, ecosystems, and human rights. AIDA works in close collaboration with partner organizations throughout the Americas on specific projects, and also provides a forum for groups to jointly design and apply solutions to shared environmental problems.

AIDA's mission is to:

Strengthen people's ability to guarantee their individual and collective right to a healthy environment, via the development, implementation, and effective enforcement of national and international law.

AIDA's projects include efforts to promote the human right to a healthy environment, protect marine biodiversity, develop mechanisms for citizen participation in government decision-making, combat climate change, and safeguard freshwater resources. We strive to ensure that international policies, laws, and financial flows contribute to, rather than compromise, environmental protection. We focus on using international strategies, with multinational AIDA teams collaborating to establish precedents that will have regional and long-term impacts.

AIDA's main program service is to provide legal support in international and environmental law. Below, we present a list of all cases AIDA litigated and projects where we provided legal support this fiscal year. No fees are sought or recovered for any of AIDA's casework.

LITIGATION AND ADVOCACY BEFORE INTERNATIONAL TRIBUNALS OR DISPUTE RESOLUTION MECHANISMS

BRAZIL

AIDA is representing Brazilian indigenous communities in a key human rights case before the Interamerican Commission on Human Rights (IACHR), to protect the communities, their lands, health, and livelihood in face of the substantial threats posed by the construction of the Belo Monte Dam, the world's third largest. AIDA's effort and advocacy before IACHR could potentially benefit 20,000 indigenous persons and peasants in the region. This year IACHR opened the case, which required the State of Brazil to respond. AIDA filed a reply brief and the Commission is waiting for Brazil to answer. We helped generate a visit to Altamira, the city nearest the dam, from the UN Working Group on Business and Human Rights. The Group denounced human rights violations and, in a report to the UN

Human Rights Council, attributed responsibility to the construction consortium and BNDES. AIDA also provided information to the UN Special Rapporteur on the Rights of Indigenous Peoples, who visited affected communities. Her report to the Human Rights Council addressed many of our claims.

COLOMBIA

In Colombia's highest court, AIDA helped to win a ruling that bans mining in páramos. On the request of plaintiffs in the case, AIDA submitted an amicus brief with arguments against mining based on international environmental laws. No other brief contained these arguments, which the Court used to set a legal precedent by holding that páramos must be protected because they are carbon sinks, biodiversity hotspots, and wetlands of international importance. While the case was litigated, we prevented construction of the proposed Angostura gold mine in Santurbán páramo. We supported a National Movement of Páramos Defenders, uniting organizations in advocacy.

We also held the International Finance Corporation (IFC) accountable for its decision to invest in the Angostura mine. We prepared an analysis of legal protections for páramos and submitted it to IFC's ombudsman. The ombudsman found that IFC did not properly consider the economic and political effects of the mine's impacts on biodiversity. For the time being, the Angostura mine has been stopped. Now there is little chance that large-scale mines will be built in Colombian páramos. Getting to this point for páramo protection is the result of many years of persistent effort and a strategic combination of legal, communications and advocacy work.

AIDA prepared a Ramsar petition with local communities and NGOs, Universidad del Norte, and the University of Florida; we requested an Advisory Mission and expert technical assistance from the Ramsar Secretariat to support the Colombian government in protecting Ciénaga Grande, a critical wetland at the mouth of the Magdalena Basin. After our request, the government assumed it as theirs and also asked Ramsar to conduct the mission. The mission occurred in August 2016, improving the treaty's implementation in Colombia's domestic legal system and raising the profile of the wetland in Colombia and internationally. Significant media coverage and public debate increased pressure on the government to protect Ciénaga Grande.

On behalf of local communities in Tolima, AIDA submitted a follow-up report to the Ramsar Secretariat about the potential impacts of La Colosa gold mine. AIDA also provided legal expertise to the coalition supporting citizen efforts to protect their water.

GUATEMALA

AIDA provides legal expertise in monthly calls of the Coalition Against Unjust Mining in Guatemala (CAMIGUA), and provides legal assistance to international NGOs and local lawyers regarding human rights and environmental violations at the

Marlin Mine. In May 2014 the Inter-American Commission on Human Rights (IACHR) issued an admissibility report, and AIDA and the Center for International Environmental Law (CIEL) are preparing an *amicus curiae* brief in support of the case. At a meeting in Washington DC, AIDA provided CAMIGUA with legal expertise regarding processes and legal claims before the Inter-American Commission on Human Rights.

MEXICO

On behalf of a coalition of stakeholder groups, AIDA advocated against a 2012 government decision to reduce the size of Mexico's Veracruz Reef System. The Veracruz reef is considered the main coral ecosystem in the Gulf of Mexico, and the government's actions sever two key reefs from the protected area in violation of Mexican environmental law and various international treaties. Collectively we are asking Mexico to adopt compensation and remediation measures in accordance with international law. AIDA provided legal support to the Mexican Center for Environmental Law (CEMDA) in two legal actions, one about inadequacies in the Environmental Impact Statement and the other seeking to block mining in Los Tuxtlas Biosphere Reserve.

In response to a proposed hydropower project in Las Cruces, Nayarit that would bring severe harm to a unique mangrove area, as well as to indigenous communities along the last remaining free-flowing river in Mexico, AIDA provided legal support to affected communities in Sinaloa and Nayarit. We supplied information to the UN Working Group on Business and Human Rights, which studied the dam's impacts on affected communities. We also supported CEMDA in litigation over inadequacies in the Environmental Impact Assessment used to approve a water permit.

PANAMA

At the request of Centro de Incidencia Ambiental (CIAM), AIDA filed an *amicus* brief supporting CIAM's lawsuit seeking annulment of the Environmental Flow Resolution, which allows up to 90 percent of the water in rivers, lakes, and other natural sources to be used in large projects such as hydroelectric dams.

PERU

AIDA provided legal representation and communications services to residents of La Oroya, victims of lead poisoning and other toxic impacts caused by emissions from a multi-metal smelter. We documented ongoing health harms, advocated with the government to implement a health plan (the Heavy Metals Strategy) for the clients, and provided updated information in litigation before the Inter-American Commission on Human Rights. AIDA presented several communications to local institutions and the Inter-American Commission on Human Rights, seeking to maintain the budget allotment for the Heavy Metals Strategy, a specialized healthcare system; in September 2015, the Regional Council of Junín approved the budget. In May 2016 the Commission asked the Peruvian government to protect 14 more people whose health suffers from exposure to toxic pollution. We

also provided legal expertise in monthly meetings of the Technical Group on Air Quality.

LEGAL SUPPORT, NON-LITIGATION

BOLIVIA

In July 2016 AIDA created the Bolivian Environmental Justice Network with 18 civil society organizations, academic institutions, and citizens concerned about the environment. The Network aims to improve public debate, generate information and arguments, and take collective action on issues including energy policies, the expansion of the extractive frontier in the Amazon, and weak or nonexistent access to constitutional and environmental justice for the protection of the right to healthy and balanced environment.

CHILE

AIDA participated in the public consultation on Chile's National Climate Change Action Plan. We also trained civil society advocates in Chile about the contributions dams make to climate change at a Citizens' Roundtable on Climate Change.

COLOMBIA

AIDA and allies in Colombia and the U.S. collected almost 25,000 signatures on a petition calling on Colombia's president and Minister of Justice to end widespread aerial spraying of a toxic herbicide used for more than 20 years to eradicate coca and poppy crops. The government suspended the spraying on September 30, 2015, in response to calls for protection of the environment and human health.

AIDA continued to provide training, legal counseling, and communications support to local organizations working to protect páramos (high-altitude wetlands) from mining projects. We also contribute to protective strategies for threatened environmental activists.

In Colombia AIDA formed a coalition of organizations that generated a legal strategy to oppose La Colosa mine, so as to protect a farming area that produces food for Tolima and Bogota. We petitioned international authorities to press Colombia to uphold treaties, advised the community in a legal challenge, and convinced local councils to hold public referendums about the proposed mine. If a local referendum results in a vote against the mine, it will be the first time a Colombian community uses that process to protect its right to a healthy environment.

AIDA hosts monthly meetings and training sessions for members of the Network for Environmental Justice in Colombia, to build capacity in environmental law and environmental protection among civil society actors in Colombia. This

capacity building brings direct benefits to more than 100 environmental advocates as well as indirect benefits to communities they work with throughout Colombia.

COSTA RICA

The Costa Rican government appointed AIDA attorney Gladys Martinez to provide expertise in international and comparative law to the Consejo Nacional Asesor de Humedales en Costa Rica, which is developing a national wetlands policy.

HONDURAS

In Honduras, we trained government representatives on climate finance mechanisms and on requirements for successful proposals.

MEXICO

AIDA and the Mexican Center for Environmental Law (CEMDA) responded to the government's call for public comments on the Environmental Impact Assessment of a proposed underwater phosphate-mining project. Our legal analysis spurred the mining company to revise its plans; for now, the mine has been stopped.

At the invitation of Mexico's Ministry of Interior, AIDA worked with the Focal Group on Business and Human Rights to prepare the National Mexican Action Plan on Business and Human Rights.

AIDA provided legal expertise to Mexico's National Institute of Ecology and Climate Change (INECC). The Institute is using AIDA's input in its evaluation of Mexico's climate change policy.

REGIONAL EFFORTS

Marine biodiversity protection

AIDA works to develop and advocate for improved national and international policies to allow Latin American nations to end indiscriminate fishing practices and reduce overall fishing efforts, adopt precautionary fishing policies, protect coastal habitat, and develop economic incentives and systems that will facilitate the transition to sustainable marine resource use.

AIDA produced a webinar on Marine Mining and Environmental Impact Analysis: The Don Diego Project in Mexico. Sixty-three people attended.

AIDA became a member of the High Seas Alliance, which is drafting a treaty to protect marine life in international waters.

We continued to collaborate as a member of The International Coral Reef Initiative (ICRI), which enables us to work more closely with countries involved in the management of coral reefs in the Americas.

Preventing adverse environmental and human impacts from hydroelectric dam and extractive projects

AIDA continued to coordinate meetings of the Latin American Alliance on Fracking, which developed a coordinated strategy to limit and prevent harms from this oil and gas drilling technique. Membership grew to 40 organizations from eight nations. AIDA also produced a regional webinar on Advances in Fracking in Latin America, attended by 117 people.

AIDA worked with the Alliance to influence the language of the European and Latina American Parliament's resolution on the opportunities and challenges of shale gas. As a result the final text "Emphasizes that it is essential that the precautionary and 'polluter-pays' principles are applied to any future decisions about the exploitation of fossil fuel resources."

We published *The Precautionary Principle: A Legal Tool for Dealing with the Impacts of Fracking*, in collaboration with the Heinrich Böll Foundation. We launched the report in La Paz, Bolivia, generating international media coverage. More than 500 government officials, community representatives, students, and journalists received the report. Organizations in Colombia and Argentina have already used the report's main arguments in their efforts to limit fracking.

AIDA produced a training seminar on fracking in La Paz, Bolivia, which 40 members of civil society attended.

Business and Human Rights

AIDA spurred the Inter-American Commission on Human Rights to hold a hearing on business and human rights; we testified about barriers to access to justice.

Capacity building for human rights and environment lawyers

AIDA organizes and participates in workshops, conferences and events around the world to help educate environmental and human rights lawyers regarding national and international environmental and human rights law, the links between environmental degradation and human health, and mechanisms for using human rights law to protect public health in cases of severe environmental contamination.

AIDA made a presentation on human rights and the environment in Central America before the Economic, Social and Cultural Rights Unit of the Inter-American Commission on Human Rights. We also held a capacity-building workshop in Mexico City for 20 civil society representatives from five nations.

Environmental Governance, International Financial Institutions and Climate Change

AIDA participated as one of very limited Latin American civil society representatives at board meetings of the Green Climate Fund, a United Nations

based entity. Our efforts contributed to board decisions to adopt a comprehensive accountability framework; create an information disclosure policy that ensures public participation; heighten review of accredited entities; require funded projects to meet international standards and comply with national laws; and to increase transparency.

AIDA organized webinars on the Green Climate Fund ahead of the board meetings to help participants prepare and allow for prior discussion of key issues. We invited board members from Latin America to participate and share their perspectives and priorities, encouraging dialogue and information exchange between board members and participants in the region. Each December, AIDA attends the Conference of the Parties of the United Nations Convention Framework on Climate Change (COP) as a panelist, to share our perspectives. We also attend pre-COP meetings, where we organize meetings of key stakeholders and provide textual input to negotiators from Latin America. After the COPs, we organized webinars at which more than 100 people heard about the new climate accord.

For interested regional stakeholders, AIDA produced a webinar on the Green Climate Fund's Readiness and Preparatory Support Program, which provides resources to help countries access climate finance. One hundred fifteen people participated.

AIDA's webinar on its original report, "Short-Lived Climate Pollutants: Current Situation and Opportunities for Reduction and Control in Brazil, Chile and Mexico" attracted 100 participants from the region.

At an event organized by Colombia's Ministry of Environment and the University of the Andes, AIDA made a presentation to members of government, civil society organizations, and academia about implementation of the Minamata Convention, an international treaty on control of mercury.

At the World Bank Policy Forum, AIDA moderated a session on Sustainability of Large Dams as Energy Solutions.
